swim lesson inquiry. You may contact Dan at 572-1231.

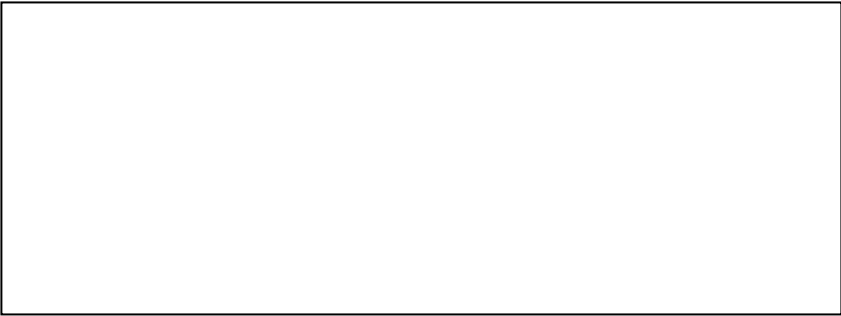
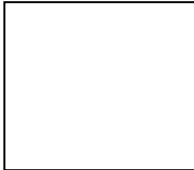
